## Athena Development Program Terms and Conditions

1. ADP participation is subject to the Terms and Conditions stated herein. Acceptance in the program will be granted, and may be revoked, at the sole discretion of AGC.
2. As part of the consideration for participation, the student hereby agrees to remain a student and pay the Program Fee for the term of the class. The student will be billed for the entire Program Fee or on a monthly basis if payment in full has not already been made.
3. Students may select one of the following methods of payment for their Program Fee (if paid by monthly installments): Automatic monthly credit/debit payment from a Visa, MasterCard, American Express or Discover or authorized ACH payment from a designated bank account. A \$20 fee will be assessed for any automatic debit that is rejected for insufficient funds or any failed credit charge.
4. All students must review, agree to the terms of, and sign the Adult Release, Assumption of Risk and Indemnity Agreement. All students must also obey the ADP Code of Conduct at all times.
5. All students are subject to the general policies and rules of operation and administration by AGC, all of which are intended to provide a safe, professional, friendly and family-oriented club.
6. Any student may be suspended or expelled from the range and/or facility for violation of the Code of Conduct or for behavior deemed unsafe by AGC personnel. Decisions of AGC regarding suspension or expulsion are final. Code of Conduct booklet shall be issued to each student during Indoctrination Phase.
7. A student may be unilaterally terminated by AGC if, in the sole discretion of AGC management, the conduct of the student presents a safety hazard to any other student or employee of AGC or to AGC facilities. In no event will there be any refund of any Program Fees paid for months past.
8. The student's acceptance shall be considered "abandoned" and terminated in the event of non-payment of the Program Fee. There is no refund of any portion of the Program Fees paid in the event of abandonment.
9. Any destruction of AGC property caused by a student, whether accidental, negligent, willful or otherwise, may result in the violator being removed from the range and/or facility, suspended or removed from the program if a student, and/or criminally prosecuted. In addition, AGC reserves the right to assess to the student a reasonable charge for any such damage, regardless of whether the damage is caused by the student or the student's guest.
10. The ultimate pass or failure of any student enrolled in the program will be at the sole discretion of the ADP Director.
11. Any ADP student that is in good standing will receive 10% off all ammunition and gear purchased while a student of the program (Firearms and Optics are not included).
12. The ADP student must be in good standing in order to be admitted to the class sessions.
13. Minimum age required for consideration for acceptance of the program is 21 years old.

## Schedule of Program Fees for Athena Development Program

- 1. Pistol Fee \$3,600.** This fee includes the use of the following: classroom materials, use of a class supplied "blue gun", Milsim pistol, striker fired .22cal handgun, striker fired 9mm handgun, striker fired 9mm Simunition™ handgun, face/neck/groin (men)/chest (women) protection, magazines, magazine pouch, holster, eye and hearing protection, targets, target material and ancillary range material. Also included is class and range time for 13 modules @ 2 hours per module. Ammunition for the course is required to be purchased from Athena and the cost of the ammunition is sold separately at an ADP student discount.
- 2. AR Fee \$2,500.** This fee includes the use of the following: classroom materials, use of a class supplied "blue gun", Milsim AR style carbine, AR style carbine .22 cal, Simunition™ AR style carbine, face/neck/groin(men)/chest(women) protection, magazines, magazine pouch, sling, AR style carbine 5.56mm, eye and hearing protection, targets, target material and ancillary range material. Students will also learn how to assemble, from parts, a complete AR style carbine. Also included is class and range time for 7 modules at 2 hours per module. Ammunition for the course is required to be purchased from Athena and the cost of the ammunition is sold separately at an ADP student discount.
- 3. AK Fee \$2,500.** This fee includes the use of the following; classroom materials, use of a class supplied "blue gun", Milsim AK style carbine, face/neck/groin (men)/chest (women) protection, magazines, magazine pouch, sling, AK style carbine 7.62x39mm, eye and hearing protection, targets, target material and ancillary range material. Students will also learn how to assemble, from parts, a complete AK style carbine. Also included is class and range time for 7 modules at 2 hours per module. Ammunition for the course is required to be purchased from Athena and the cost of the ammunition is sold separately at an ADP student discount.
- 4. Shotgun Class \$1,500.** This fee includes the use of the following: classroom materials, use of a class supplied 12 GA Simunition™ shotgun, face/neck/groin (men)/chest (Women) protection, 12 GA defense style shotgun, sling, shell pouch, eye and hearing protection. Also included is class and range time for 5 modules at 2 hours per class. Ammunition for the course is required to be purchased from Athena and the cost of the ammunition is sold separately at an ADP student discount.
